Mahalaxmi Municipality Kamalpokhari Lalitpur invites electronic bids from eligible bidders for the construction of Road Construction Work from Tikathali Ward Office to Moti Chowk Contract Identification No : GON/W/NCB/Lalitpur/Mahalaxmi/03/077/78 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Rs. 2,70,00,000.00**
- Minimum Work experience of similar size and nature: **one project with minimum value of Rs. 1,75,00,000.00**

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit the non refundable fee of Rs. 5000 of the bidding Document till 30 days during office hour ,in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Electronic bids must be submitted to the office Mahalaxmi Municipality Kamalpokhari Lalitpur through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00PM on 2077/08/09**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **01:00PM on 2077/08/09** at the office of Mahalaxmi Municipality Kamalpokhari Lalitpur . Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Rs.6,00,000 (Six Lakhs Rupees Only) which shall be valid for 30 days beyond the validity period of the bid.
